## DIRECTOR'S LETTER



KTS has completed 40 years since it was established with the aim of socio-economic upliftment for one of the most disadvantaged isolated community and poor people in the Kumbeshwar, Lalitpur, Nepal. During this long journey we have faced many challenges, but with support of friends from Nepal and around world, we've made it this far.

We have been providing academic and vocational training classes to fulfill our organization's aim and objectives. Our dedication is to empower our target group through various programs like child care, adult literacy class, health awareness, sanitation education, human rights, primary school education and vocational training as well as income generating programme. Additionally, we had provided support to differently abled individuals and women prisoners by offering hand knitting and carpet weaving training.

Thousands of children have graduated from primary school and hundreds of women and differently abled individuals have received free vocational training. Most of our graduates found job opportunities and living comfortably. More than 2000 women, differently abled individuals are producing hand knitwear at home. 99.9% of our knitwear and carpets are sold in International market, mostly through fair trade buyers. All the income including buyers support was used in our social activities. Our sales started declining since 2015 after the earthquake, affecting our order deliveries. Until 2018-2019, more than 80% of our expenses were covered by the sales of the products made in our income generating project. The impact of Covid-19 dealt a significant blow to our sales, and current global financial slowdown has greatly affected our sales and are facing a major challenge in sustaining our social and income generating activities incurring substantial losses. Despite these challenges, we remain optimistic and believe that we can increase our sales with the support of our fair trade buyers and new buyers we have acquired in recent years.

We would like to express our sincere thanks to Fair Trade buyers, friends and well-wishers especially El Puente Germany, People Tree Japan/UK, Sukha Foundation Netherlands, KASIN UK, Fair Trade Co., Korea for their valuable support. We also highly appreciate the moral and financial support from all buyers, well-wishers and friends during this difficult time. We appeal to our friends and well-wishers to continue supporting us in marketing KTS Knitwear and Carpets.

With the leadership of Chairman Rtd. Lt. Gen. S. K. Malla, we are managing to overcome current challenging situation with the help of buyers, well-wishers and friends. We would like to express our sincere gratitude to our national and international friends, well-wishers and buyers for their continued cooperation and supports.

# ABOUT KTS

Established in 1983 by former State Council Member, the late Mr. Siddhi Bahadur Khadgi, Kumbeshwar Technical School (KTS) is an educational and vocational training centre supporting the needs of low-income families throughout Nepal. As a non-profit, Fair Trade NGO, KTS believes that “equal opportunities for all” is a fundamental human right.

KTS was initially established to assist the local Pode community of street sweepers because, as a caste of untouchables, these people had been denied education and employment opportunities. The rest of society shunned them and it was virtually impossible to break free from the traditional caste occupations of street sweepers, butchers and small farmers. In 1983 a childcare project for street cleaning workers was established, followed by adult literacy classes and health clinic, including an immunisation programme.

KTS officially opened the primary school in 1987 where a carpet weaving training programme for adults was already in place and a production unit was established to fund the School. The KTS organisation today encompasses a free nursery and primary school for poor children and offers welfare and education for up to 20 orphan/semi-orphan children in the KTS orphanage. KTS provides vocational training for teenagers in carpet weaving, hand knitting and carpentry.

As a founder member of Fair Trade Group Nepal and a Guaranteed member of WFTO (World Fair Trade Organization) and WFTO Asia, KTS strongly believes in Fair Trade practices and is committed to working with its producers to create Fair Trade products. KTS has installed Fair Trade income-generating programmes to support producers and artisans, through the sale of high-quality Fair Trade carpets, knitwear and furniture. All the income from this used for KTS activities. KTS also runs a day-care centre for the children of trainees, producers and staff, free of charge.

KTS is managed by a seven-member Executive Committee, which makes all the policy decisions relating to the organisation. The Member Secretary & Director of KTS has overall responsibility for policy implementation. The KTS administrative team manages the organisation’s day-to-day running. The KTS primary school teachers’ committee bears responsibility for the Nursery and Primary School. The administration staff and a vocational teachers’ committee oversee the Vocational School.

## WHAT WE DO

KTS offers key opportunities to create a secure future. Local children from low-income families learn vital literacy skills and receive a broad and high quality education in the KTS Nursery and Primary School. Vocational training in carpet weaving, hand knitting and carpentry provides access to a wide range of employment opportunities. KTS assists in the creation of income-generating programmes that directly benefit low-income groups and, in particular, women and the physically challenged. Orphans and destitute women are offered a home, education and training. KTS also works to empower the local community and the wider population to take responsibility for themselves and their future. As a founder member of Fair Trade Group Nepal and a Guaranteed member of WFTO Global and WFTO Asia, as well as a member of Good weave Nepal. KTS strongly believes in Fair Trade practices and is committed to working with its producers to create Fair Trade products.

KTS organized “Free Women’s Health, Eye check-up and Free Cataract Surgery Camp” as well as “Menopause awareness camp on 20 May 2023 at KTS premises. In collaboration with Nepal Eye Hospital, we organized a comprehensive free Eye check-up and Treatment along with Cataract Surgery camp.

This year, 309 people benefited from the free Eye check-up and Treatment Camp. Among them 87 people were prescribed glasses. Further investigation and the cataract surgeries had been

performed at Nepal Eye Hospital by a team of skilled professionals. 10 people were diagnosed with eye cataract and 7 of them need urgent treatment. People who were diagnosed with eye cataract received free surgery at Nepal Eye Hospital, Tripureshwor. KTS distributed prescription glasses free of cost with support of KTC.

The Optometrist team from Nepal Eye Hospital, led by Optometrist Dr. Indu Prasad Dhungel along with Ophthalmic Coordinator Mr. Kalyan Dhungana, Optometrists Ms. Rita Karki and Ashish Neupane, Ophthalmic assistant Rajendra Prasad Joshi, Rohit Shaha, Ms. Sajal Shrestha and Ms. Ranjana Gurung, conducted the eye camp.

A total of 396 students, staff, parents, producers, and local residents from Lalitpur, Kathmandu, and Bhaktapur benefited from the health camp.

## CORONA VIRUS PANDEMIC

The corona virus pandemic greatly affected social and economic activities of KTS. Some of KTS executives, staffs, students and producers were infected by COVID-19. Luckily all of them recovered. Also all the hostel children were safe. KTS management faced many challenges to continue all activities.

## WELFARE OF STAFF AND PRODUCERS

This year 38 staff benefited from the medical facility of the Social Security Fund and 4 producers benefited from the medical facility of the school fund.

21 staff and 4 producers benefited from the KTS saving credit programme. Most of them used the money to renovate houses, land purchases, children's education or to extend family businesses.

KTS provided scholarships to producers' children Pramik Man Shrestha, Ranjit Tamang, Sagun Shakya and Salina Shakya. Among them Salina Shakya is studying BIT (Bachelor of Information Technology) in final year.

Similarly KTS continued the sponsorship of earthquake victim local girls Nishowna Shakya, Praneesha Shakya and Samir Shakya through the sister concern Export Company with support from El Puente, Germany.

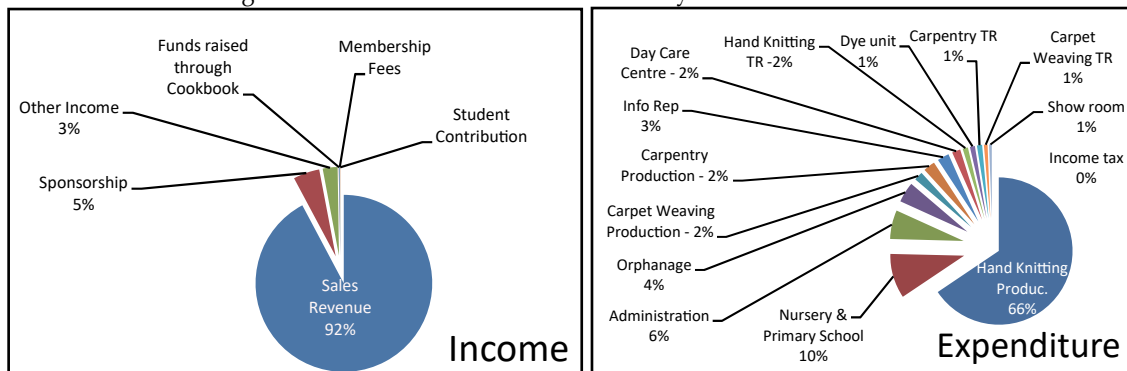

- Due to recession, the total knitwear sales decreased by 5.67% compared to last year, and 21.44% sales were below the estimated budget. The decline was primarily attributed to the adverse effects of Russia-Ukraine war and global recessions on most of our main buyers.



# ORPHANAGE

KTS orphanage was established to provide support and rescue vulnerable children from deprived communities, as well as destitute women and physically challenged boys and girls throughout the country. Over three decades, a total of 60 children were rescued and supported to become self-reliant. Among the individuals who were part of the orphanage program, two girls are working as teachers in KTS primary school, one is employed as an assistant matron in KTS Orphanage, two girls and one differently abled boy are working at KTS income-generating programs, three individuals are working in Australia, one is working in the USA, one individual is employed in France and one person is working in the UK. Most of the grown-up boys and girls are employed in various fields and are self-sustained. Additionally, two widows and one destitute woman have retired.

The orphanage provides care and support, including clothing, course books, stationery, school fees, four daily meals, healthcare, indoor games, and a conducive study environment. The organization endeavored to create a homely atmosphere for the children. However, due to a continuous decline in income from sales and support, along with the impact of global recession and the COVID-19 pandemic, the management faces significant challenges in raising funds.

Regrettably, due to these challenges, the organization has made the tough decision to temporarily suspend the orphanage program from July 16, 2023. Five children have been relocated to another orphanage in coordination with the National Child Rights Council, Nepal, and four children have been reunited with their relatives, with sponsorship promised until they complete their undergraduate degrees.

In the orphanage, four meals were served daily, including tea at 6:30 am, Nepalese Dal Bhat for breakfast at 8:30 am, snacks with tea at 4 pm, and Nepalese Dal Bhat for dinner at 7 pm. The monthly cost per child at the centre averages NPR 19,817.00.

The generous sponsorship from KASIN UK has been instrumental together with membership subscriptions and sponsorships from friends and individual well-wishers covered 45.33% of the orphanage expenses. The remaining 54.67% of the expenses were covered by the reserve fund of KTS.

# NURSERY AND PRIMARY SCHOOL

The new session of primary school started in accordance with schedules set by the local government. KTS is following government curriculum and supplements it with additional books to ensure quality education. With start of new session government changes the course book necessitating us update the course books. However, there are challenges in changing to new books due to the current book market system whereby whole set of books needed to be changed instead of only one subject which proves costly for the organisation during present financial crisis. Despite these challenges all the programmes are running smoothly as per operation calendar.

In our effort to provide best possible education we have incorporate audio visual classes. Basic computer literacy classes. Additional, there are library classes to enhance knowledge and encourage reading habits among students, with collection of international children's books. This supports children's development and motivate them to study and cultivate reading habits.

The annual teachers' workshop was conducted, where all the teachers share their experiences and develop lesson plan collaboratively. This year the classes and all the extra curriculum's activities have been carried out smoothly.

KTS is committed to children's health recognising that many young students suffer from malnutrition due to their parents' poverty. Therefore KTS provides daily free snacks to playgroup to Kindergarten children. 47 children enjoy snacks twice a day, while 18 children in kindergarten classes and enjoy one snack daily. Since KTS's establishment, around 6,000 children from deprived and marginalized families have received care. It is heartening to mention that six graduates of our primary school have returned to KTS as teachers and contributing to the ongoing education of new generations.

This year, teachers organized education tour in Patan Museum for students in grade 2 to 5. Three senior high school students from USA volunteered at KTS for few weeks. They shared their experiences with KTS students. It was wonderful and exciting experience for both the US students, who learned about life of Nepalese children from marginalized families, and KTS students, who gained insight into American student life and culture.

In the academic year 2022 / 2023, 136 ( 74 boys and 62 girls ) children enrolled from playgroup to grade 5. Out of these 134 children (73 boys and 61 girls, including 2 boys and 2 girls from the local street sweeper community and rest from local and migrated poor families) completed and appeared in the final sent-up evaluation.

Contributions from valued buyers, friends, well-wishers and the Friends of Kumbeshwar Kids membership programme plus bank interest from fixed deposit funds have helped to run the Nursery and Primary School.

# DAY-CARE CENTRE

Children in the Day Care Centre thoroughly enjoy their time there. The teachers and caretakers provide careful attention based on the children's age, catering to those as young as 45 days old up to 10 years. The staff follows a daily schedule, including playtime, naptime, and snack breaks. There is no time restriction for breastfeeding, offering considerable relief to staff, trainees, and producers who can keep their children close.

The center operates for 8 hours a day (9 am to 5 pm) and provides snacks twice a day from Sunday to Thursday, with one snack on Fridays.

On average, 14 children stay the entire day, with 5 more arriving around 2 p.m. An additional 7 children join during school holidays, making an average of 26 children attending each day. The children are taken care of by one teacher and two caretakers. The monthly cost for the center averages NPR 2,837.00, and parents contribute NPR 25 per month for each child.

This year, 45.74% of the expenses were covered by the support from valued buyers, friends, well-wishers, and Friends of Kumbeshwar Kids members, while 54.26% was covered by bank interest from fixed deposits and the reserved fund.

# VOCATIONAL TRAINING

KTS remains committed to offering free vocational training in Hand knitting, Carpet weaving, and Carpentry (Furniture making) to underprivileged individuals, particularly women and differently abled, who are above 15 years old. The carpet and carpentry training comes with a tea allowance and a job guarantee, contributing to the sustainability of their lives. KTS emphasizes practical knowledge, facilitating graduates in finding employment more easily.

In the fiscal year 2022/2023, there was significant interest in vocational training, but only a few individuals were able to join due to uncertain pandemic-related situations. KTS adapted its training schedule based on demand rather than following the annual operation calendar, considering the uncertainties and unfavourable conditions faced by marginalized communities due to both international and national pandemics. KTS management collaborated with local governments in Lalitpur district, requesting recommendations for needy young individuals to participate in the training. Banepa Municipality expressed interest in conducting short-term hand knitting training in the area.

This year, KTS continued a demand-oriented short-term hand knitting with sewing training, focusing on Doll making, and offered job opportunities for interested women. During the training, participants received NPR 50 per hour.

KTS has provided skills training to more than 2127 women, 366 men, 121 differently abled women, 17 differently abled men, and 95 women prisoners. In total, 2,726 individuals have completed hand knitting training through the program. The school continues to offer all existing vocational training programs free of charge.

# HAND KNITTING TRAINING

Doll making training was continued with tea allowances. 12 trainees joined in 1st batch and 5 in the 2nd batch among them 10 trainees completed the training and 7 dropped out. In the regular hand knitting training we had only one batch with 3 trainees out of which 2 of them completed it.

The Banepa Municipality requested us to organise a short term basic hand knitting training for women of Banepa. KTS appointed group leader Ms. Binda Manandhar, from Banepa to conduct the training. She was provided her with KTS knitwear training curriculum and orientation on conducting the training. Seventeen women participated in the training, and KTS sponsored 4 of them. After completing the training, they joined the Banepa knitting group and are now receiving knitting work from KTS.

The doll making trainees was provided with tea allowance in order to enable them to dedicate time for learning new skill to improve their income. After training trainees who showed real aptitude joined income generating programme as independent artisans at KTS.

The hand knitting training is two hours a day, five days a week for three months with knitting homework. It is scheduled from 11:30am to 13.30pm for convenience to household women. Doll making training is three hours a day.

Since the inception of our vocational training program, 2039 people (1,817 women, 119 differently abled women, 6 men, 2 differently abled men and 95 women prisoners in the Central Women's Prison, Kathmandu) have benefited from hand-knitting training.

# CARPET WEAVING TRAINING

There is a high demand for carpet weavers in the country, especially as the carpet industry is gradually recovering. With carpet weavers being scattered in the past due to the slowdown in the carpet business and the pandemic, the resurgence of the industry has led to an increased demand for skilled carpet weavers. Carpet weaving training is particularly relevant and beneficial for marginalized individuals, especially women and those with disabilities, who may not have formal education. The training allows individuals to acquire skills within a few months, making it easier for them to secure employment and become independent, particularly for those who have migrated from hill areas of the country. Recognizing this, KTS continues to focus on carpet weaving training for disadvantaged individuals.

To reach the target community, KTS actively promotes the training through local government channels, community engagement, and social media. The carpet weaving short-term training program lasts for 4 months (34 hours a week, totalling 390 hours of training) following the curriculum set by the Council for Technical Education and Vocational Training (CTEVT). Additionally, there is an 8-week on-the-job training component. During the training period, KTS provides a tea allowance of NPR 150 per day.

In the current year, the carpet weaving short-term training started with 4 participants in the first batch, followed by two in the second batch and two in the third batch. After completing the training, graduates have the opportunity to work at KTS's income-generating program until they find jobs in other carpet industries of their choice.

Since the inception of the vocational training program, 330 individuals (including 310 women, 11 men, 2 differently-abled women, and 7 differently-abled men) have benefited from the carpet weaving training program.

# CARPENTRY TRAINING

In the country, there is a significant demand for carpenters. Many skilled and semi-skilled carpenters come to work from other countries. Unfortunately, due to a lack of knowledge and proper guidance, young teenagers often prioritize jobs in Gulf countries without having the necessary skills and work experience. This leads to exploitation and abuse in their workplaces.

Low-educated and marginalized individuals often lack the patience to undergo skill training before seeking employment abroad. KTS is working to advocate for these people, emphasizing the importance of acquiring skills to secure good jobs and achieve independence. The aim is to raise awareness about the value of skills, encouraging individuals to prioritize training for a better future and a more independent life.

This year, we admitted 5 trainees to the carpentry training programme. Out of them, 3 boys completed the training and 2 finished their on-the-job training at different times. One boy doing on-the-job training will continue next year due to the flexible enrollment schedule.

KTS is continuing its short term training programme primarily focusing on teenagers. The course follows the CTEVT (Council for Technical Education and Vocational Training) curriculum, a 390 hours course and KTS provides further 9 months on-the-job training in the income generating unit. After completion of training, the trainees become skilled enough to sit on the level II skill test exam, the minimum qualification for a job in Nepal.

The Carpentry graduates can obtain work immediately after training either locally or in Gulf countries, but young people are less attracted on the training due to lack of information about the market, patience, high expectations as well as the allure of the Gulf countries. However, considering the usefulness and importance of the skill and its high potential, KTS is continuing training programme.

Since the inception of our vocational training programme, 357 people (355 boys and 2 differently abled boys) benefited by carpentry training programme.

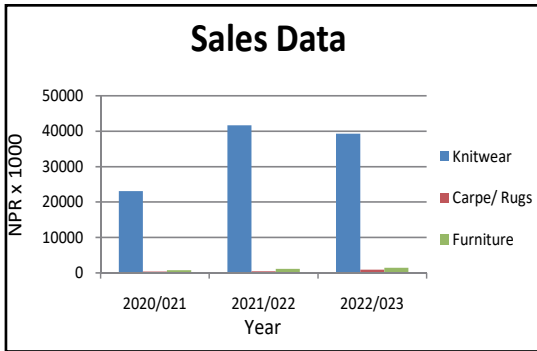
Currently, KTS providing NPR 200 per day to trainees to partial support for their living costs. This allowance is helpful in supporting them while they are in training. KTS provides a set of hand tools used by each student on the completion of the training.

Minimum qualification required for trainees is grade five and the programme is open to anyone older than 15 years.

To ensure the sustainability of our organization, KTS has established income-generating programs that provide job opportunities for our graduates and support the financial needs of our organization. The income generated from these programs is utilized in our social activities. Despite facing challenges such as the 2015 earthquakes, we have continuously developed with the support of Fair Trade buyers.

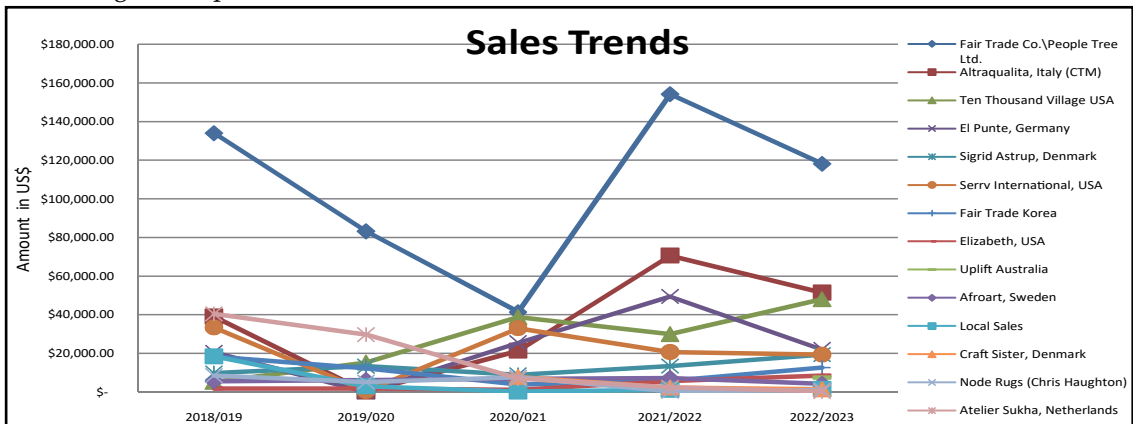
However, the devastating earthquake disrupted our production flow, impacting our efficiency and production capacity. Subsequently, our income-generating programs have faced additional

challenges, including the Covid-19 pandemic, Dengue endemic, global economic recessions, and the Russia-Ukraine war. These challenges have affected the sales of our hand-knitwear and carpet products, leading to financial difficulties.

Despite the diligent efforts of our buyers to promote our products in the international market, the ongoing uncertainty of the global market due to the Russia-Ukraine war is a growing concern. We are anxious about the impact of these challenges on our ability to cover the expenses of our activities, particularly our initiatives such as free child education and free vocational training.

As a certified Fair Trade, non-profit organization, KTS follows the ten Fair Trade Standards set by the World Fair Trade Organization in all our operations. Our team consists of 76 staff members, and we collaborate with over 2,000 home-based hand-knitwear producers, 25 carpet producers, and approximately 15 supporting producers. Directly, we provide benefits to about 2,040 producers, and indirectly, we impact over 10,000 individuals, including their families, through KTS's income-generating programs.

The income-generating programs at KTS offer fair wages based on a piecework basis. In addition to fair compensation, we provide various benefits to our producers, including medical insurance, health awareness programs, and saving credit facilities. Furthermore, we offer sponsorship for the children of our producers who may face challenges in affording the costs of education. This holistic approach aims to support the well-being and future prospects of our community members, ensuring a more sustainable and inclusive impact on their lives. Our commitment to Fair Trade principles ensures that our operations contribute positively to the livelihoods and well-being of our producers and their communities.



# HAND KNITTING INCOME GENERATING PROG.

In our hand knitting income generation program, we focus on producing high-quality hand-knitwear with the aim of reaching the international market and aligning with current trends. We also create new designs for home accessories, staying in line with international trends. Our emphasis is on using natural materials like sheep wool for winter products and cotton for summer items. Additionally, we make efforts to incorporate locally sourced natural fibers such as banana fiber, Allo (Nettle Fiber), and hemp, promoting local materials and reducing our carbon footprint in production.

Approximately 2,000 marginalized women, including 25 differently-abled women and some men, work as home-based knitwear artisans in our program. We provide job opportunities for nine months in a year, with a focus on utilizing local materials and promoting sustainability.

However, challenges arise, particularly in the summer season, as our sales are seasonal, and there are fewer orders during this period. Despite efforts to diversify our product range with home accessories and summer items, it has been challenging to maintain consistent orders throughout the year, especially since 2015. This decline has impacted both our artisans and KTS's ability to carry out its social activities.

This year, we managed to use raw materials from previous years' stock with significant support from our buyers, helping with our cash flow. However, our knitwear sales have decreased by 5.67% compared to last year, and they are 21.44% below our estimates. The challenges are attributed to the effects of the pandemic, the Russia-Ukraine war, and subsequent global recessions. These factors have created hurdles, affecting both our sales and our ability to carry out social initiatives.

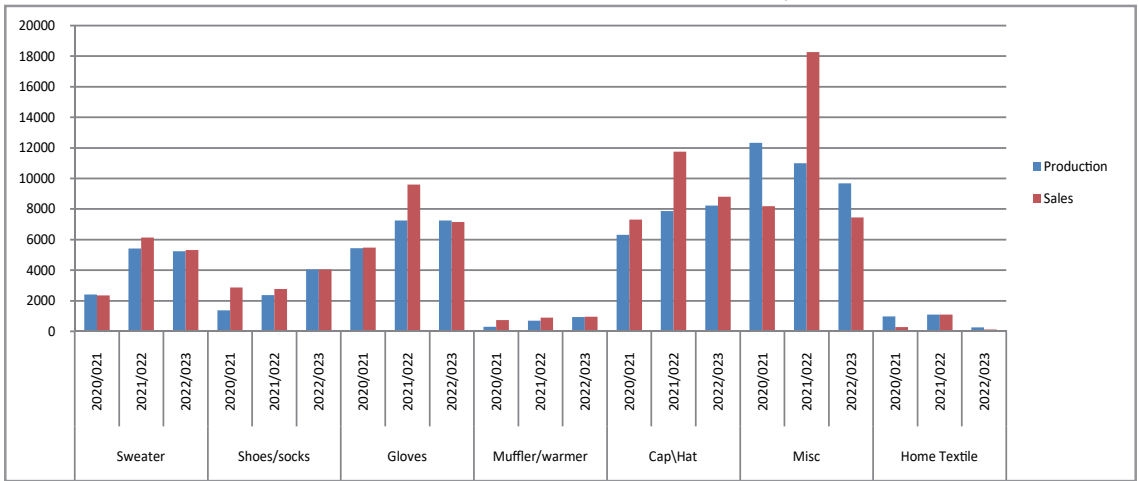

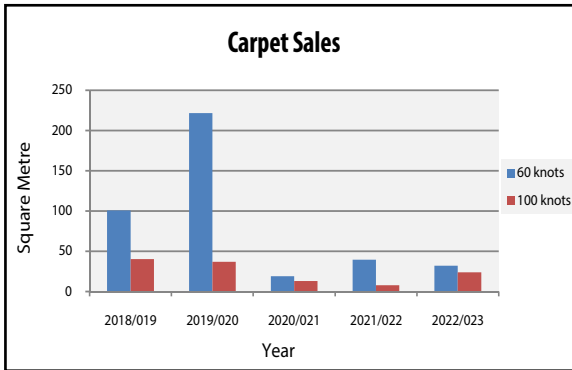

# CARPET WEAVING INCOME GENERATING PROG.

In our carpet production unit, we are placing a strong emphasis on creating high-quality custom design carpets with the collaboration and support of interior designers, artists, friends, and well-wishers.

The sales of our carpets have faced significant challenges due to the impact of the Covid-19 pandemic. Despite these challenges, we are actively working to promote carpets made with local materials, particularly those crafted from banana fiber. Our commitment to innovation was recognized when our Banana carpet, featuring a modern abstract design, won the

award for the best innovative home decor product at the Mohammad Islam Design Competition during the World Fair Trade Organization Summit 2022 in Berlin.

As a result of this achievement, the carpet is now listed under the WFTO store on Ebay UK as part of the Ebay for Change initiative. The Secret Project in the UK is supporting us in marketing the carpet on Ebay and in the UK market. Encouraged by this success, we are designing more banana yarn rugs and exploring the use of other locally made materials, such as Sunpat and allo, to create new carpets and products. We hope that people will appreciate our new developments and extend their support to our efforts in promoting sustainable and innovative carpet designs.

Currently, our reliance is entirely on individual customers and buyers, presenting a substantial challenge in maintaining consistent employment for our artisans. Due to a substantial stock of carpets, we are compelled to slow down production and clear the existing inventory until demand picks up. The support of illustrator Mr. Chris Haughton and some individual customers has been crucial in allowing us to sustain our program during this challenging period.

We hope that KTS's well-wishers, friends, and customers will understand the situation and assist us in clearing the existing stock by placing orders for KTS handmade woollen or banana carpets. Your small contribution will be immensely helpful to us financially and will enable us to provide opportunities for our artisans to earn a living.

In the carpet production unit, there are currently 2 wool spinners, 5 carpet weavers, 1 trimmer, and 2 dyers diligently working. Your support will not only help sustain our program but also contribute to the livelihoods of these artisans.

The carpentry unit regularly receives furniture orders from KTS staff, well-wishers, and partner organizations like Associations for Craft Producers. These orders create job opportunities for On-the-Job Training (OJT) trainees and staff, keeping everyone busy.

The Carpentry Income Generating Programme is beneficial for On-the-Job trainees. They gain hands-on experience in making different types of furniture. Additionally, they learn how to create small, useful, and low-cost furniture using leftover materials. The program also provides lessons on repairing old furniture. Trainees work on customer orders using quality materials like wood, ply, tic, and block board, with direct assistance from a trainer. It's also a great way to learn practical skills like managing production time, handling materials, figuring out costs, and dealing with customers.

The program extends its services to repairing furniture in the KTS primary school and office. This not only helps maintain and improve the furniture in these places but also provides additional practical work opportunities for trainees.

This year the carpentry unit has a surplus, which is very valuable for organization contributing to its finances and sustainability.
